WHEREAS, The City of San Diego is the owner of an easement for temporary road purposes in Lot 1 of Torrey Knolls Park; and

WHEREAS, the Engineering & Development Department has requested that the City quitclaim to SORRENTO PARTNERS, a general partnership, its interest in and to said easement; and

WHEREAS, the owner of the property wishes to clear title to his property; and

WHEREAS, the herein-described property is surplus to City needs; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and

WHEREAS, no real estate broker's commission shall be paid; and

WHEREAS, the sale of the aforementioned property is consistent with the public interest; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That that certain real property right described in that quitclaim deed on file in the office of the City Clerk as Document No. RR-260499, be, and the same is hereby determined to be surplus and is hereby authorized to be sold by negotiation for the sum of NINE HUNDRED DOLLARS (\$900) to SORRENTO PARTNERS, a general partnership.
- 2. That the Mayor and City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, which is on file in the office of the City Clerk as Document No.

 RR- 260499 , quitclaiming to SORRENTO PARTNERS, a general partnership, that certain easement, as more particularly described in said quitclaim deed.
- 3. That no broker's commission shall be paid by City on the herein described negotiated sale.
