BE IT FURTHER RESOLVED, that the acceptance by the City Manager of that street reservation deed of BURTIS CORPORATION, a Delaware corporation, executed in favor of The City of San Diego, bearing date of January 16, 1984, a copy of which deed is on file in the office of the City Clerk as Document No. RR- 260503-2, granting to said City a reservation for future street purposes in a portion of Lot 1 of Palisades Plaza, Map 5199, as more particularly described in said deed, be and the same is hereby approved.
