

RESOLUTION NUMBER R- 260510

Adopted on APR 23 1984

WHEREAS, on June 22, 1983, the City through its Purchasing Agent, advertised for competitive bids by means of a Request for Quotation (Bid 5153Q) sent to potential bidders to provide tree maintenance as required for Scripps Miramar Open Space for a period of twelve (12) months beginning July 1, 1983, through June 30, 1984, and

WHEREAS, at the time the City requested quotations, the estimated cost of maintaining trees in Scripps Miramar Open Space for a period of one year did not exceed \$10,000, and

WHEREAS, PEDERSEN TREE SERVICE ("PEDERSEN") responded to the City's request for quotations by offering a bid of \$36.00 per hour, with a two-hour minimum, and

WHEREAS, in accordance with his authority under San Diego Municipal Code Section 22.0504, the Purchasing Agent awarded the contract to Pedersen, the lowest responsible bidder, and accepted the contract by a series of purchase orders, the total of which to date has not exceeded \$10,000, and

WHEREAS, it is now apparent that the amount of tree maintenance in Scripps Miramar Open Space is greater than originally estimated, and may require an additional expenditure

of up to \$3,000 more than originally estimated to maintain the trees for the full term of the contract, and

WHEREAS, the City continues to have a need for tree maintenance in Scripps Miramar Open Space, thereby requiring modification of the contract for the purpose of increasing the total allowable expenditure under the contract by an additional \$3,000.

NOW, THEREFORE, BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to execute on behalf of the City of San Diego The First Amendment to Agreement with PEDERSEN TREE SERVICE for providing as required TREE MAINTENANCE FOR SCRIPPS MIRAMAR OPEN SPACE for the period of twelve (12) months beginning July 1, 1983 through June 30, 1984, on file as Document No. RR-260510 with the Office of the City Clerk.

BE IT FURTHER RESOLVED, that the sum of \$3,000 is authorized for the sole purpose of payment of the costs of work to be performed under this First Amendment to Agreement.
