("SDG&E") and the City Manager is authorized to retain an appraiser for an amount not to exceed \$30,000 for the purpose of establishing the value of the SDG&E street lights.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is authorized to add CIP Project No. 37-317 "SDG&E Street Light Acquisition and Conversion" to the FY 1984 Capital Improvements Program.

BE IT FURTHER RESOLVED, that the expenditure of \$2,400,000 from the Special Litigation Liability Reserve (No. 65011) for the purpose of acquiring these lights and converting them to Low Pressure Sodium Vapor lighting is hereby authorized.

BE IT FURTHER RESOLVED, that the City Manager is directed to repay the \$2,400,000 to the Special Litigation Liability Reserve in the Annual Budget from future utility bill savings.
