BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract on behalf of the City with SIGNS & PINNICK, INC., for the sum of their Base Bid and

Deductive Alternate 1 (totaling \$339,807.00) and upon the terms and conditions of the specifications on file in the office of the City Clerk as Document No. 118079.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$50,000.00 from Park Service District Fund 16723 and the sum of \$18,000 from Capital Outlay Fund Unallocated Reserve, CIP No. 90-245, to CIP No. 29-183 PALM RIDGE NEIGHBORHOOD PARK -ACQUISITION AND DEVELOPMENT.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$68,000.00 from CIP No. 29-183 PALM RIDGE NEIGHBORHOOD PARK -ACQUISITION AND DEVELOPMENT to supplement funds previously authorized by Resolution No. 260020, adopted on January 30, 1984, is hereby authorized solely and exclusively for providing funds for said project and related costs.
