

RESOLUTION NUMBER R- 260540

Adopted on APR 23 1984

BE IT RESOLVED, by the Council of The City of San Diego, that the Planning Department staff is hereby directed to testify at State Mining and Geology Board hearings on April 27, 1984 and recommend to this Board the five-point position outlined in Planning Report No. 84-170, as modified by the Rules Committee to include:

(a) Changing Recommendation 3 to read "NOT DESIGNATE those areas which are designated by the City for planned urbanization which would be incompatible with mining activity."

(b) Exclude from designation the 100-acre CONROCK-Carroll Canyon property west of Camino Ruiz.


(c) Exclude from designation the 58-acre Carroll Creek property on either side of Camino Ruiz east of Fenton-Carroll Canyon and south of CONROCK-Carroll Canyon holdings.

(d) Exclude from designation that property owned by the Grant Family Trust and Mr. Russell Grant in Mission Valley and Serra Mesa with the exception of the property north of Friars Road under lease to CONROCK.
