
RESOLUTION NUMBER R- 260543

Dear Mr. Chairman:

We commend the Port Commission for its nationwide design competition and process that led to the selection of the Erickson, Deems/Lewis architectural team.

However, after speaking with many of our council colleagues, it appears that there are some legitimate concerns that we hope will be considered by the Port and the design team prior to negotiation of an operating agreement between the City of San Diego and the Port District.

We feel it incumbent upon us to remind all concerned that the City Council expressed a very strong desire to construct a highly functional and architecturally imaginative convention center within a budget of \$95 million.

Therefore, we would like to request that the City Council be allowed to participate in the approval of the final architectural design of the facility prior to final decision by the Port. To accomplish this, we request that the Council receive periodic public presentations by the Port in order to assure that our concerns are understood and addressed.

It is our hope that modifications can be made to build a facility for \$95 million that will not diminish the architectural quality that we all desire.
