WHEREAS, it is recognized that the "Senior Fire Protection Program," officially begins April 24, 1984; and

WHEREAS, this community service program has been developed by the I.B.E.W. Local 569's Union Electricians' Community Service Network, the San Diego City Firefighters Local 145, and the San Diego City Fire Department; and

WHEREAS, this program is designed to reduce the number of fire-related injuries and deaths among low-income senior citizens of San Diego; and

WHEREAS, the program provides free smoke detectors, installation, and related fire safety information to the low-income seniors in the Golden Hill and adjacent areas as part of a 90-day pilot program; and

WHEREAS, expansion of the program is anticipated; and


