Bonita R. Gillespie	General Services	\$ 330.00	Ms. Gillespie is an Intermediate Typist in the Administration Division. She suggested that the road which runs through the 20th and "B" Operations Station be named so that the Post Office could deliver the mail to each division. This is expected to save \$1,096.32 in the first year in time savings.
Valdimir Kisak	Park and Recreation	\$ 100.00	Mr. Kisak is a Grounds Maintenance Worker II in the Coastal Division. He suggested changing the method of installing and preparing basketball nets, to help prolong their service life. This was considered to be a significant operational improvement.
David L. Meyer	General Services	\$ 70.00	Mr. Meyer is a Carpenter in the Buildings Division. He suggested that a step be installed on the side of truck 5313. This is expected to save \$236.04 in the first year in time savings.
