APPROVING PARCEL MAP TM 82-0534

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain parcel map surveyed by James H. Algert, a registered civil engineer, identified as "PARCEL MAP TM 82-0534, being a Parcel Map of Lot A-111 of Addition No. 1 to San Ysidro, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 1194 filed in the office of the County Recorder of San Diego County July 13, 1909," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said parcel map and the division of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: portions of Sycamore Road and Boston Avenue, and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use, as dedicated and shown on said parcel map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Boston Avenue, adjacent and contiguous to Parcel 1, as shown on this parcel map within this division of land.

BE IT FURTHER RESOLVED, that said Council hereby accepts on


behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of water facilities, as granted and shown on said parcel map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said parcel map, as and for the act of the Council, that said Council has approved said parcel map and that said portions of public streets are accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of water facilities, all as granted and shown on this parcel map within this division of land, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
