APPROVING PARCEL MAP TM 83-0558

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain parcel map surveyed by Ronald C. Parker, a licensed land surveyor, identified as "PARCEL MAP 83-0558, being a division of Pueblo Lot 1302 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pasco in 1870, a copy of which said map was filed in the office of the County Recorder of San Diego County, and known as Miscellaneous Map No. 36," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said parcel map and the division of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public Pulitzer Place, and said street is hereby declared to be a public street and dedicated to the public use, as dedicated and shown on said parcel map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby rejects, on behalf of The City of San Diego, a municipal corporation, as a dedication a portion of Parcel 2 marked "Reserved for Future Streets," as shown on this parcel map, under the provisions of Section 66440 of the Government Code.

The Clerk of said City is hereby authorized and directed to

endorse upon said parcel map as and for the act of the Council,
that said Council has approved said parcel map and that said
public street is accepted on behalf of the public as heretofore
stated, and that said Council has rejected a portion of Parcel 2
marked "Reserved for Future Street."

The Clerk of said City is hereby directed to transmit said
parcel map to the Clerk of the Board of Supervisors of the
County of San Diego, California.
