PACIFIC PRODUCTS, INC. are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of LAWN SPRINKLERS AND IRRIGATION VALVES AND SPRINKLER REPAIR PARTS as may be required for a period of one (1) year beginning May 1, 1984 through April 30, 1985, with an option to renew contracts for an additional one (1) year period; per prices on file in the Purchasing Department as follows:

1. HYDRO-SCAPE PRODUCTS, INC. for Group I - Toro Sprinklers and Parts; Group III - Buckner Sprinklers and Parts; terms 2% 30 days, plus sales tax.

3. PACIFIC PRODUCTS, INC. for Group IV - Hydro Rain Irrigation Valves and Parts; terms 4% 30 days, plus sales tax.
