

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the bids of 1. CASE POWER AND EQUIPMENT and 2. TELELECT WEST are hereby accepted and the City Manager is hereby authorized to execute contracts for the purchase of SIX (6) EACH TRAILERS, as follows:

- 1. CASE POWER AND EQUIPMENT for Item 1 Two (2) each Elevator Trailers at a cost of \$3,743.00 each, and Item 2 One (1) each Tilt Bed Trailer, 12,000 lb. capacity, at a cost of \$4,274.00 each; for a total cost of \$11,760.00; terms net 30 days, plus sales tax.
- 2. TELELECT WEST for Item 3 Three (3) each Tilt Bed Trailers, 24,000 lb. capacity, at a cost of \$7,453.00 each, plus an option for two (2) standard 20,000 lb. axles and four (4) spring suspension with torque arms on each trailer at a cost of \$1,118.00 each (cost per trailer to be \$8,571.00 each) for a total cost of \$25,713.00; terms net 30 days, plus sales tax.
