BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

BARRIO LOGAN CDBG SIDEWALK IMPROVEMENT - LOGAN AVENUE FROM 16TH STREET TO 26TH STREET.

BE IT FURTHER RESOLVED, that the total expenditure of \$236,000.00, not to exceed \$200,000.00 from CDBG Fund 185191, Dept. 5731, Org. 3112; not to exceed \$20,000.00 from CDBG Fund 18517, Dept. 5990, Org. 9001, REMOVAL OF ARCHITECTURAL BARRIERS; and not to exceed \$16,000.00 from Capital Outlay Fund 30245, CIP No. 58-007, OVERHEAD AND OTHER CITY COSTS FOR PROJECTS FUNDED BY FEDERAL GRANTS is hereby authorized solely and exclusively for providing funds for said project and related costs.
