

RESOLUTION NUMBER R- 260594

Adopted on MAY 07 1984

BE IT RESOLVED, by the Council of The City of San Diego, that the acceptance by the City Manager of those street easement deeds of PARDEE CONSTRUCTION COMPANY, a California corporation, and JERRY L. ELDER, all executed in favor of The City of San Diego, bearing dates of March 1 and March 2, 1984, copies of which deeds are on file in the Office of the City Clerk as Documents No. RR- 260594-1, RR- 260594-2, RR- 260594-3, RR- 260594-4 and RR- 260594-5, granting to said City easements for public street purposes in portions of Sections 18 and 19, Township 14 South, Range 3 West, San Bernardino Meridian, as more particularly described in said deeds, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for public streets, and Parcels A, B and C are hereby named EL CAMINO REAL, Parcels D and F are hereby named DEL MAR HEIGHTS ROAD, and Parcels E and H are hereby named DEL MAR HEIGHTS WAY.

That the City Clerk shall cause the deeds and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
