BREN COMPANY, a California corporation, all of the City's right, title and interest in the sewer and drainage easements, as more particularly described in said quitclaim deed.

2. That the City Clerk is hereby directed to cause a certified copy of this resolution, with deed, attested by him under seal, to be recorded in the office of the County Recorder.
