

RESOLUTION NUMBER R- 260626

Adopted on MAY 07 1984

BE IT RESOLVED, that the Council of The City of San Diego, hereby accepts the generous donation of \$120,000 from the Boys' Club of San Diego, Inc., a non-profit organization, for the purpose of funding a public gymnasium facility to be located at the Encanto Park, 6785 Imperial Avenue.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with Boys' Club of San Diego, Inc., a non-profit organization, to construct a gymnasium facility at Encanto Park, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 260626.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the sum of \$35,000 from Fund 18518, Department 5610, Organization 1001, Block Grant Administration, to Fund 18518, Department 5613, Organization 1307, Encanto Boys' Club, is hereby authorized.

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$374,700 from CDBG Fund 18518, Department 5613, Organization 1307, and \$145,000 from Fund 18519 Department 5713, Organization 1306, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
