WHEREAS, on December 5, 1983, the Council of the City of San Diego adopted Resolution No. R-259733 which authorized the City Manager to issue a Request for Proposals for consultant services to design a noise monitoring system for Montgomery Field; and

WHEREAS, by Resolution No. R-259733 the Council also authorized an expenditure not to exceed \$30,000 from the Airports Enterprise Fund for the exclusive purpose of paying for the consultant's services once the consultant was selected, and

WHEREAS, the Request for Proposals was issued and proposals have been received from eight qualified acoustical consultants, and

WHEREAS, the Council finds that the proposal of WYLE LABORATORIES best meets the needs of the City in designing a noise monitoring system for Montgomery Field;

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with WYLE LABORATORIES, a California Corporation, to provide professional consulting services for design of a Noise Monitoring System and Strategy for developing

sound level limits for Montgomery Field, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 260634 .
