BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer the amount of \$2,000.00 from CIP No. 58-004, Miscellaneous Improvements on City Streets, to CIP No. 52-296, Route 52 - Santo Road to State Route 67.

BE IT FURTHER RESOLVED, that the expenditure in the amount not to exceed \$55,193.00 from Capital Outlay Fund 30245, CIP No. 52-296, Route 52 - Santo Road to State Route 67, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
