BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute, subject to compliance by SAI with the terms of said Option to Purchase, a Custom Agreement of Sale with SAI, pursuant to which SAI would acquire a fee interest in Lot 2, Campus Point Phase II, for the sum of \$4.47 million which is the appraised value of said property as of January 1, 1984, said property constituting approximately 7.6 gross acres located 400 feet westerly from the northwest corner of Campus Point Drive and Campus Point Court, and pursuant to which agreement SAI or its designated principal would construct not less than 100,000 square feet of improvements for office and research facilities and ultimately employ not less than 250 employees on said Lot 2, under the terms and conditions set forth in that Custom Agreement of Sale on file in the office of the City Clerk RR- 260640 - 2 as Document No.

BE IT FURTHER RESOLVED, that the Mayor and the City Clerk are hereby authorized to execute a Grant Deed, a copy of which is on file in the office of the City Clerk as Document No. RR-  $260640^{-5}$ , conveying said Lot 2 to SAI.

BE IT FURTHER RESOLVED, that no Broker's fee shall be paid by the City in connection with this sale.

BE IT FURTHER RESOLVED, that this sale is by negotiation rather than auction because SAI owns the adjacent Lot 3 of Campus Point Phase II and wishes to expand its corporate headquarters and related facilities on Lot 2.

BE IT FURTHER RESOLVED, that the payment of the expenses of the sale are hereby authorized from the proceeds of the sale.

BE IT FURTHER RESOLVED, that the balance shall be deposited in Fund 30248, Capital Outlay, Account 78333, Police Substation.
