

RESOLUTION NUMBER R- 260649

Adopted on MAY 8 1984

WHEREAS, this City Council has been advised that the National Football League will be entertaining proposals to host the Super Bowl for certain future years commencing in 1987; and

WHEREAS, this City Council has been advised that in order to be considered for such an event certain representations as to the host city's responsibilities must be made; and

WHEREAS, having been fully advised of these responsibilities and the pledges of the community of San Diego to assist in meeting these commitments; and

WHEREAS, The City of San Diego is most desirous of hosting a Super Bowl in our community; and

WHEREAS, San Diego is ideally suited by having conveniently located visitor facilities and tourist attractions to host this prestigious event; and

WHEREAS, San Diego has been home to the National Football League San Diego Chargers for the past 23 years; and

WHEREAS, San Diego has never hosted a Super Bowl; and

WHEREAS, the City government and the local business community are absolutely committed to providing the very best in facilities and ambiance for a Super Bowl event; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to submit a proposal to the National Football League to host the Super Bowl at San Diego Jack Murphy Stadium which will commit the City to provide:


- a. Use of San Diego Jack Murphy Stadium which will have a seating capacity in excess of 75,000 spectators at no cost to the National Football League.
- b. Press level facilities modified to accommodate the press corps.
- c. The cooperation of all City resources including Police Department, Fire Department, Stadium, Airports, etc.
- d. A guarantee that Stadium concession prices will be held at the same price level as that which prevailed during the previous National Football League season.
- e. A guarantee that taxicab rents will be held at the same price level as that which prevailed during the last quarter prior to the Super Bowl event.
- f. A guarantee that adequate power and communication facilities will be provided for all necessary services.
- g. A commitment to cooperate with the National Football League to prevent the unauthorized sale of National Football League licensed merchandise.
- h. The provision of adequate practice field facilities at no cost to the National Football League.

i. A guarantee that all concession and parking revenues normally due the City will be passed through to the National Football League.

BE IT FURTHER RESOLVED, that Mayor Hedgecock represent the City at the May 24, 1984 meeting with the National Football League in Washington, D.C.
