BE IT RESOLVED, by the Council of The City of San Diego as follows:


Said Council hereby finds that certain map surveyed by Thomas S. W. Wong, a registered civil engineer, entitled "SARA LYNN'S SUBDIVISION UNIT NO. 1, being a subdivision of that portion of Lot 2 of the Subdivision of the East Half of Pueblo Lot 1215, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 690 filed in the office of the County Recorder of said County October 31, 1891," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public a portion of Stalmer Street, and said portion of street is hereby declared to be a portion of a public street and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portion of a public street is accepted on behalf of the public as heretofore stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
