RESOLUTION NUMBER R- 260671

Adopted on MAY 14 1984

WHEREAS, Section 8330 et seq. of the California Streets and Highways Code provides a procedure for the summary vacation of an excess right-of-way of a street or highway not required for street or highway purposes; and

WHEREAS, the adjacent property owner has requested the vacation of a portion of 39th Street adjacent to Lot 23 of Block 444, Duncan's Addition, Map 403, to unencumber his property; and

WHEREAS, the portion of street to be vacated is not needed for present or prospective public street purposes; and

WHEREAS, those properties adjoining the portion of street to be vacated will continue to have access; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; and

WHEREAS, the vacation is not inconsistent with the General Plan or an approved Community Plan; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the portion of 39th Street adjacent to Lot 23 of Block 444 of Duncan's Addition, Map 403, as more particularly shown on Drawing No. 15797-B on file in the office of the City Clerk as Document No. RR- 260671-, which is by this

reference incorporated herein and made a part hereof, be and the same is hereby ordered vacated.

2. That the City Clerk shall cause a certified copy of this resolution, with drawing, attested by him under seal, to be recorded in the office of the County Recorder.
