

RESOLUTION NUMBER R- 260680

Adopted on MAY 14 1984

WHEREAS, at the March 27, 1984 Rules Committee meeting, the Intergovernmental Relations Department was directed to report to the Rules Committee on what, if any, action the County of San Diego was taking to reduce funding for health and social services within The City of San Diego; and

WHEREAS, Intergovernmental Relations Department staff has discussed this issue with County staff, and has researched County staff reports and Board of Supervisors' actions on the County 84-85 budget; and

WHEREAS, at the February 28, 1984 meeting of the Board of Supervisors, the County Administrative Officer was directed to develop a "management plan" for securing the cooperation of the cities within the County in funding these contract agencies beginning in FY 85-86, it being apparent that the Board's action is in preparation for the possibility of a significant reduction in County commitment of its revenue sharing funds to contract agencies; and

WHEREAS, the reduction or elimination of County funding for health and social contract services would undoubtedly have impact upon the residents of The City of San Diego; and

WHEREAS, in recognition of the Board of Supervisors' discretionary authority and the impact their decisions may have on residents of this City, it is considered advisable that this

Council assure continued monitoring of the County's budget actions and provide input as appropriate; and

WHEREAS, the full details of the County's apparent thrust is set forth in the report of the Intergovernmental Relations Department, IRD Report No. 84-17, dated April 4, 1984, entitled "Information Report on County Health and Social Services Funding;" and

WHEREAS, the information was reviewed and approved unanimously by the Rules Committee on April 9, 1984; and

WHEREAS, it was recommended in said report that the City Council be kept advised by the Board and be given an opportunity for input on any actions involving County revenue sharing funding of contract agencies and that the City Manager maintain the required contact with County staff in order to monitor and analyze proposed actions by the County; and


WHEREAS, the Rules Committee now forwards said action to the full Council, recommending approval of those recommendations contained therein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that in accordance with the information presented in and recommendations presented by the Intergovernmental Relations Department Report No. 84-17, dated April 4, 1984, the Mayor is hereby authorized to formally advise the County Board of Supervisors of the City's significant interest in the issue of County revenue sharing funding of contract agencies.

BE IT FURTHER RESOLVED, that the City Council be kept advised of and given an opportunity to provide input on any Board decisions in regard to the above.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby directed to establish necessary contact with County staff to enable the City Manager to monitor and analyze the County's proposed actions in this regard and report to the City Council as may be appropriate.
