RESOLUTION NUMBER R- 260682

Adopted on MAY 14 1984

WHEREAS, Coupons Number Five (5) due June 1, 1983, each in the face amount of \$287.50 detached from City of San Diego Hospital Bond, Hospital Revenue Bond (Children's Hospital), Series A, Bond Numbers 2488, 2489, 2490, and 2491, each for \$5000.00 maturing on December 1, 2010, bearing an interest rate of eleven and one-half (11.5) per cent, were lost, stolen, or destroyed on or about June 10, 1983, while in the care, custody, and control of Purolator Armored, Inc., and the coupons have not been found or paid, and

WHEREAS, a "Duplicate Document Bond", on file in the Office of the City Clerk as Document No. RR-260682, has been executed by duly authorized representatives of Purolator Armored, Inc., as principal, and Insurance Company of North America, as surety, which agreement indemnifies and holds the City of San Diego and Bank of America, NT and SA, harmless for twice the face amount of the lost coupon (\$2,300.00), and

WHEREAS, the City of San Diego must authorize approval of the payment before the Paying Agent, Bank of America, makes payment for the lost coupons.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City

of San Diego that the payments to the bondholders by the Bank of America NT & SA for the above-described lost coupons No. 5 detached from Bond Numbers 2488, 2489, 2490 and 2491 are hereby authorized. '
