RESOLUTION NUMBER R- 260683

WHEREAS, Coupon Number Twenty-four (24) due June 1, 1983, in the face amount of \$110.00 detached from City of San Diego 1966 Municipal Series 4, Bond No. 718 for \$1500.00, maturing on December 1, 1986, bearing an interest rate of four and four-tenths (4.4) per cent, was lost, stolen, or destroyed on or about June 10, 1983, while in the care, custody, and control of Purolator Armored, Inc., and the coupon has not been found or paid, and

WHEREAS, a "Duplicate Document Bond", on file in the Office of the City Clerk as Document No. RR-260683, has been executed by duly authorized representatives of Purolator Armored, Inc., as principal, and Insurance Company of North America, as surety, which agreement indemnifies and holds the City of San Diego, Bank of America, NT and SA, Citibank, and First National Bank of Chicago, harmless for twice the face amount of the lost coupon (\$220.00), and

WHEREAS, the City of San Diego must authorize approval of the payment before the Paying Agent, Bank of America, makes payment for the lost coupons.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City

of San Diego that the payments to the bondholders by the Bank of America NT & SA for the above-described lost coupons No. 24 is hereby authorized.
