WHEREAS, Section 8 of the Annual Salary Ordinance No. O-  
16214 (New Series), for fiscal year 1985, provides  
that those classified personnel who shall be eligible for and  
entitled to receive overtime compensation shall be approved by  
Council resolution after determination by the Civil Service  
Commission and City Manager and/or nonmanagerial department  
head; and

WHEREAS, the classifications now recommended to the Council  
have been appropriately determined to be so eligible and are  
submitted for Council approval; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,  
that pursuant to the authority of Section 8 of the annual salary  
ordinance the classifications of personnel in the classified  
service of The City of San Diego eligible for premium or regular  
rate overtime, as set forth in Exhibits A and B attached hereto,  
are hereby approved for such status in accordance with the terms  
and conditions recited therein, for the period of July 1, 1984  
through June 30, 1985.
