

RESOLUTION NUMBER R- 260699

WHEREAS, SAN DIEGO CEMETERY ASSOCIATION, a California corporation, "Owner," and THE GENTRY COMPANY, a California corporation, "Permittee," filed an application under Municipal Code Section 101.0506 to amend Conditional Use Permit No. 4120 to remove from said Permit 7.21 acres of property located north of Carroll Road and West of Brown Deer Road, described as Lot 1, El Camino Memorial Park, Map No. 4719, in the Mira Mesa Community Plan area; and

WHEREAS, on March 29, 1984, the Planning Commission of The City of San Diego made its findings of fact, approved Conditional Use Permit No. 83-0375 amending CUP-4120, and filed said decision in the office of the City Clerk on May 1, 1984;

BE IT RESOLVED, that the Council of The City of San Diego hereby grants Owner/Permittee's request for an amendment to CUP-4120 under Conditional Use Permit No. 83-0375 to delete from the Conditional Use Permit 7.21 acres pursuant to the request of the permittee.
