APPROVING MAP OF EASTGATE MALL

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Phillip S. Butcher, a licensed land surveyor, entitled "EASTGATE MALL, being a subdivision of a portion of Lot 13 of Barrow's Subdivision, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 704, filed in the office of County Recorder of San Diego County, March 4, 1892, lying northerly of the center line of Road Survey 304 as granted to the County of San Diego by deed recorded June 10, 1927 in Book 1268, page 198 of deeds, together with portions of Eastgate Mall and Olson Drive as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: portions of Eastgate Mall and Olson Drive, and said portions of streets are hereby declared to be portions of public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the

construction and maintenance of sewer facilities, as granted and shown on said map and subject to the conditions set forth thereon.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for open space over a portion of Lot 1, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said portions of public streets are accepted on behalf of the public as heretofore stated; that the easement with the right of ingress and egress for the construction and maintenance of sewer facilities, as well as the easement for open space, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
