quitclaiming to NOBEL PROPERTIES, a California partnership, all the City's right, title and interest in the water and access easement, as more particularly described in said quitclaim deed.

2. That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
