RESOLUTION NUMBER R- 260731

Adopted on MAY 21 1984

WHEREAS, there were relinquished to the City of San Diego certain abutter's rights of access in and to Carmel Mountain Road from Lot 136 of Penasquitos Knolls East, Map 9039; and

WHEREAS, SOUTHERN CALIFORNIA DISTRICT ADVISORY BOARD, INC. has requested that the City revest certain portions of said access rights to allow for two twenty-four foot driveways; and

WHEREAS, a portion of said abutter's rights should be revested in the property; and

WHEREAS, the access rights were relinquished at no cost, and SOUTHERN CALIFORNIA DISTRICT ADVISORY BOARD, INC., a California corporation, has paid all City costs in connection with processing the matter of revesting the access rights; and

WHEREAS, the processing costs of revestment will be the consideration for the sale of the City's rights; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, a copy of which is on file in the office of the City Clerk as Document No. RR- 260731 , quitclaiming to SOUTHERN CALIFORNIA DISTRICT ADVISORY BOARD, INC., a California corporation, all the City's right, title and interest in the abutter's rights of access, as more particularly described in the quitclaim deed.

2. That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
