
RESOLUTION NUMBER R- 260735

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a supplemental agreement with CALTRANS, increasing the total construction cost for the Fairmount Avenue/Montezuma Road bikeway from approximately \$234,000 to \$271,000.00, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR- 260735.

BE IT FURTHER RESOLVED, that the reallocation of funds in the amount not to exceed \$38,800.00 of Local Transportation Funds (LTF) from the Linda Vista Road/Ulric Street bikeway project to the Fairmount Avenue/Montezuma Road bikeway, is hereby authorized, solely and exclusively for the purpose of providing funds for the above project.
