

RESOLUTION NUMBER R- **260739**

Adopted on MAY 21 1984

WHEREAS, the San Diego region's housing market is not meeting the need for affordable housing, especially for lower income households; and

WHEREAS, the lack of affordable housing creates an economic and social strain upon the San Diego region's prosperity; and

WHEREAS, the local jurisdictions in the San Diego region have approved the San Diego Association of Governments' Housing Allocation Formula and the Regional Housing Needs Statement, dated January 14, 1984, which demonstrate a commitment to address their "Fair Share" of the region's lower income housing needs; and

WHEREAS, the updated Regional Housing Needs Statement provides information that meets State requirements (Sections 65580, et seq. of the California Government Code) for a portion of the Local Housing Elements and/or Housing Assistance Plans; and

WHEREAS, the Regional Housing Needs Statement has been updated to be consistent with the time frame required for the revised housing element; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City of San Diego recognizes the housing needs and supports the goals as recommended in the updated Regional Housing Needs Statement, dated January 14, 1984.

BE IT FURTHER RESOLVED, that The City of San Diego will continue to provide housing for lower income households within its jurisdiction through all reasonable programs and activities.

BE IT FURTHER RESOLVED, that The City of San Diego has found that its Housing Element is generally consistent, or will be adjusted so as to be generally consistent, with the updated Regional Housing Needs Statement.
