BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible bidder for

METRO PUMP STATION NO. 2 SIXTH PUMP INSTALLATION.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer within Sewer Revenue Fund 41506, \$1,493,743.00 from CIP No. 46-075 POINT LOMA - METHANOL PLANT to CIP No. 46-083 METRO PUMP STATION NO. 2 - ADDITIONAL PUMPS.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$3,708,244.00 from Sewer Revenue Fund 41506, CIP No. 46-083 METRO PUMP STATION NO. 2 - ADDITIONAL PUMPS is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
