Vincent S. Fletcher	General Services	\$2,680	Mr. Fletcher is an Equipment Mechanic. One year ago he earned a partial award of \$1,065, for his suggestion to rebuild the worn out clutch housings on the Allison transmissions, instead of replacing them. One year's experience has shown a savings of \$12,486. This is the remainder of his award.
David L. Gerber	General Services	\$2,500	Mr. Gerber is a Refrigeration Mechanic in the Buildings Division. He suggested that electronic timers be installed at the Central Police Station to shut-down the air handlers in unoccupied rooms. This is expected to save \$24,457.35 in the first year.
