Burness Gipson	Water Utilities	\$ 440	Mr. Gipson was an Equipment Technician II in the Metro Division at the time of his suggestion. He suggested that a scrap metal bin be placed at the Point Loma Treatment Plant. This is expected to save \$1,461.84 in the first year.
Charles E. Lundy James Cerone	Water Utilities	\$ 260	Mr. Lundy and Mr. Cerone are Welders in the Systems Division. One year ago they earned a partial award of \$260 for their suggestion to purchase a radialgraph burning machine to reduce the time it takes to make meter cover parts. This is the remainder of their award.
Michael Eacobellis	General Services	\$ 245	Mr. Eacobellis was a Mechanic in the Equipment Division at the time of his suggestion. He originally earned a partial award of \$10 for his suggestion to galvanize all the springs and u-bolts on Lifeguard vehicles. This has shown a savings experience of \$2,536.32. This is the remainder of his award.
