WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

Charlie Jones	Water Utilities	\$ 105	Mr. Jones is a Plant Mechanic in the Quality Division. He suggested that thicker split collars be manufactured in-house, instead of purchasing them from an outside vendor. This is expected to save \$355 in the first year.
Veronica McCune	General Services	\$ 50	Ms. McCune was an Intermediate Typist in the Buildings Division at the time of her suggestion. She suggested that a manual be developed for the mailroom. Although savings were difficult to identify, this was considered to be a significant operational improvement.
Nancy Lovell	General Services	\$ 45	Ms. Lovell is a Payroll Clerk in the Streets Division. She suggested that Personnel and the Auditor's office figure final termination payoffs on the Payoff Identification Notice, instead of the present method. This is expected to save \$155.20 in the first year.
