

BE IT RESOLVED, by the Council of The City of San Diego as follows:

- 1. That the bid of \$223,632.57 by DYNO CONSTRUCTION, INC., a corporation, for the CONSTRUCTION OF WILSON UNIVERSITY AVENUE DRAIN CHEROKEE AVENUE TO WIGHTMAN STREET in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefore in accordance with the specifications on file in the Office of the City Clerk as Document No. 118190.
- 2. That the City Auditor and Comptroller is hereby authorized to transfer within Capital Outlay Fund 30245, \$36,000.00 from CIP No. 58-004 ANNUAL ALLOCATION MISCELLANEOUS IMPROVEMENTS ON CITY STREETS to CIP No. 12-051 WILSON STREET DRAIN.
- 3. That the expenditure, not to exceed \$36,000.00 from Capital Outlay Fund 30245, CIP No. 12-051 WILSON STREET DRAIN to supplement funds previously authorized by Resolution No. 260208, adopted on March 5, 1984, is hereby authorized solely and exclusively for providing funds for said project and related costs.
