

RESOLUTION NUMBER R- 260780

APPROVING MAP OF HIGH COUNTRY WEST
UNIT NO. 5 RESUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Charles W. Christensen, a registered civil engineer, entitled "HIGH COUNTRY WEST UNIT NO. 5 RESUBDIVISION, being a subdivision of Lots 1 to 6, inclusive, of High Country West Unit No. 5, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 10370, filed in the office of the County Recorder of San Diego County, April 12, 1982, together with Willowood Drive, Windrose Court and Windrose Way, as closed and vacated to public use, together with portions of Turtleback Road, Maturin Drive and Bernardo Center Drive, as dedicated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: Willowood Drive, Windrose Court, Windrose Way, Sunnyfield Place and Sunnydale Court, and said streets are hereby declared to be public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any

and all abutters' rights of access in and to Maturin Drive, adjacent and contiguous to Lots 43, 98 and 99; in and to Turtleback Road, adjacent and contiguous to Lots 99 through 106, inclusive, all as shown on this map within this subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement for open space over, under, upon and across Lot 42, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated, and that the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as well as the easements for open space, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.


BE IT FURTHER RESOLVED, that the City Clerk is hereby directed to record the street vacation of Windrose Way, Windrose

Court and Willowood Drive, approved by Council Resolution No.
R-260226 on May 5, 1984, concurrently with the filing of the
map.

The Clerk of said City is hereby directed to transmit said
map to the Clerk of the Board of Supervisors of the County of
San Diego, California.
