WHEREAS, this Council desires to make application to the Local Agency Formation Commission of San Diego County, pursuant to the provisions of the District Reorganization Act of 1965 (Government Code Section 56000 et seq.), for the reorganization described herein; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

- 1. Pursuant to Government Code Sections 56195 and 56140, application is hereby made to the Local Agency Formation Commission of the County of San Diego for a proposed reorganization as follows:
 - a. This proposal is made pursuant to the District Reorganization Act of 1965 (Government Code Section 56000 et seq.).
 - b. The nature of each proposed change of organization and the names of all districts and cities for which any such change of organization is proposed are as follows:
 - (i) Annexation of the territory described in Exhibit A attached hereto to the City of San Diego.
 - (ii) Detachment of the territory described
 in Exhibit A attached hereto from the San Diego
 County Flood Control District Zone 2.

- c. The territory proposed to be annexed and detached is uninhabited and a description of the exterior boundaries of such territory is contained in Exhibit A attached hereto.
- d. This proposed reorganization does not request the formation of a new district or districts.
- e. It is proposed that the reorganization be made subject to the following terms and conditions:
- f. The reasons for this proposal are as follows:
 This reorganization would eliminate an unincorporated
 island by annexing the territory to the City of San
 Diego. The City can provide services to this area
 more economically. The City currently provides flood
 control services within its boundaries.
- g. It is hereby requested that proceedings be taken for the reorganization as hereinabove proposed.
- 2. Pursuant to the California Environmental Quality Act of 1970 and Section 15060 of the California Environmental Quality Act Guidelines, the project designated "Daley Island Reorganization" is exempt from the preparation and review of environmental documents.
- 3. The City Clerk is hereby authorized and directed to file a certified copy of this resolution with the Executive Officer of the Local Agency Formation Commission of the County of San Diego.
