
BE IT RESOLVED, by the Council of The City of San Diego, that the Planning Director of The City of San Diego is hereby authorized to file an application initiating reorganization proceedings on approximately 234 acres of land located within the County of San Diego and known as the Daley Island; said reorganization proceedings to consist of annexation to the City of San Diego and detachment from the San Diego County Flood Control District - Zone 2.

BE IT FURTHER RESOLVED, that the transfer of funds from the Unallocated Reserve to cover payment of the State Board of Equalization fee of \$2,100 for costs associated with the "Daley Island Reorganization," is hereby approved.

BE IT FURTHER RESOLVED, that the factors to be considered as designated in Paragraph 5 of Council Policy 600-1 are hereby waived.
