KRUEGER and BETTY JEAN KRUEGER, executed in favor of The City of San Diego, bearing date of November 9, 1982, a copy of which deed is on file in the Office of the City Clerk as Document No. RR- 260802, granting to said City an easement for public street purposes in a portion of Lots 20-22, Block 22 of Lexington Park Subdivision, Map No. 1696, as more particularly described in said deed, be, and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street, and the same is hereby named JUNIPER STREET.

That the City Clerk shall cause the deed and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
