

RESOLUTION NUMBER R- 260807

Adopted on MAY 29 1984

WHEREAS, Section 64.0404 of the San Diego Municipal Code provides that sewer service charges may be established by resolution of the City Council upon the giving of ten (10) days' notice of intention to establish, amend or increase said charges; and

WHEREAS, said notice has been given by posting the intention to increase said charges by the City Clerk; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That pursuant to Section 64.0404 of the San Diego Municipal Code, the following sewer service charges are established:

(1) The domestic sewer service charge for each single family dwelling unit serviced by a separate water meter shall be seven dollars (\$7.00) per month.

(2) The monthly sewer service charge for all premises, other than single family dwellings serviced by separate water meters shall be in accordance with the following Classifications of nonsingle-family residence User Groups established for the corresponding Average Suspended Solids Concentrations and with corresponding rates per hundred cubic feet (HCF) of monthly water usage (assuming a normal 50%-70% ratio of sewer flow to water use):

*Class K includes all dischargers of wastewater containing average suspended solids concentration of more than 1,000 parts per million. The percent of the monthly sewer charge will be computed individually for each discharger in Class K with 127.8% to be increased by 4.27 for each 100 ppm suspended solids above 1,000.

In no case will the minimum sewer service charge be less than seven dollars (\$7.00) per month.

BE IT FURTHER RESOLVED, that this resolution shall be effective and in force on the first day of July, 1984.
