BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$455 from Capital Outlay Fund, CIP 39-004, Miscellaneous Parcels for Right-of-Way, Open Space and Other Public Purposes, for the acquisition of the above described parcel and related costs, is hereby authorized and approved.
