

RESOLUTION NUMBER R- 260817

Adopted on MAY 29 1984

WHEREAS, a companion resolution (City Attorney No. R-84-1901) authorized the City Manager to submit a grant application to fund a Foreign Trade Zone (herein "Zone") feasibility study; and

WHEREAS, in conjunction therewith, a Foreign Trade Zone Task Force, (herein "Task Force") was formed by Councilman Ed Struiksma and County Supervisors Tom Hamilton and Paul Eckert; and

WHEREAS, the Task Force will be responsible for determining whether to proceed with an application for creation of the Zone after a feasibility study and follow up marketing program; and

WHEREAS, the Task Force will be involved with the administration of the grant to the extent of developing and conducting the marketing program, as set forth in the Program Narrative, and make recommendations thereon; and


WHEREAS, it is necessary and desirable that the Task Force be formally recognized by the City Council; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Foreign Trade Zone Task Force (attached hereto as Attachment A), as more fully described and set forth in the City Manager's Report entitled "Foreign Trade Zone Feasibility Study," (with attachments thereto), a copy of which is on file in the office of the City Clerk as Document No. RR-260817 and the same is hereby formally recognized.

BE IT FURTHER RESOLVED, that Councilman Ed Struiksma be and he is hereby designated as the Council representative and chairperson of said Task Force and that Councilman Uvaldo Martinez is further designated as the alternate City Council representative.
