WHEREAS, The City of San Diego has had a legislative representative in Washington, D. C. since the early 1960's; and

WHEREAS, the City is currently represented by Mr. William Harrington, pursuant to an agreement authorized by Council on June 27, 1983; and

WHEREAS, it has been suggested that the City issue a Request for Proposal (RFP), to be developed under Council Policy 300-7, in order to secure a fixed-fee, non-exclusive representation contract for the period January 1, 1985 through June 30, 1986; and

WHEREAS, in connection therewith, it is recommended that the current agreement be extended for a six-month period to accommodate any unresolved issues which carry over to the fall congressional session; and

WHEREAS, the analysis and discussion of the above proposals are set forth in the Intergovernmental Relations Department Report No. 84-25, dated May 3, 1984; and

WHEREAS, the Rules Committee reviewed the above recommendations and IRD Report No. 84-25 and voted to recommend that the full Council adopt the proposals as submitted; and

WHEREAS, the matter is now forwarded to the full Council with a recommendation to approve as submitted; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the Director of Intergovernmental Relations be and he is

hereby directed to develop a Request for Proposal, pursuant to the guidelines of Council Policy 300-7, for the purpose of securing proposals for legislative representation in Washington, D. C., as more specifically set forth in Attachment I to IRD Report No. 84-25, dated May 3, 1984.

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby fully authorized and empowered to execute, for and on behalf of said City, a First Amendment to that certain agreement between The City of San Diego and William Harrington Associates, on file in the office of the City Clerk as Document No. RR-258798, dated June 27, 1983, to amend paragraphs 7 and 13 to reflect an extension of six (6) months until December 31, 1984, under the same terms and conditions, as more specifically set forth in Attachment II to IRD Report No. 84-25, dated May 3, 1984.
