WHEREAS, in approving the final maps of Park Village Estates Units 1, 2, 3 and 4, the City shall receive easement interests which will allow the abandonment of existing sewer and drainage easements and abutter's rights of access; and

WHEREAS, said easements and abutter's rights of access have never been used for the purpose for which they were acquired and the City Manager has recommended the City abandon its interest therein; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, as follows:

RR- 260850 - 1 and RR- 260850 - 2, which are by this reference incorporated herein and made a part hereof.

2. That the City Clerk shall cause the drawings and a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
