APPROVING MAP OF PARK VILLAGE ESTATES UNIT NO. 3

BE IT RESOLVED, by the Council of The City of San Diego as follows:

Said Council hereby finds that certain map surveyed by Robert G. Schoettmer, a licensed land surveyor, entitled "PARK VILLAGE ESTATES UNIT NO. 3, being a subdivision of Lots 112 through 125, inclusive, 242, 243, 244, 245, 251 through 256, inclusive, 261 through 288, inclusive, 293, 294, 297 and 298, and portions of Lots 126, 201 through 210, inclusive, 215, 216, 217, 234, 235, 236, 246, 247, 248, 249, 250, 257, 258, 259, 260, 289, 290, 291, 292, 295, 296, 299, 300, 301, 302 and 304 of Penasquitos Park View Estates Unit No. 2, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 10046, filed in the office of the County Recorder of San Diego County March 30, 1981, together with a portion of Black Mountain Road as dedicated to public use, and together with Pimpernel Drive, Pimpernel Way, Gambusa Place, Gambusa Way, and Amaranth Street as closed and vacated to public use," is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public the following: Pimpernel Drive, Pimpernel Way, Gambusa Way, Gambusa Place and Amaranth Street, and said streets are

hereby declared to be public streets and dedicated to the public use, as dedicated and shown on said map and subject to the conditions set forth thereon.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, any and all abutters' rights of access in and to Black Mountain Road, adjacent and contiguous to Lot 1 as shown on this map within this subdivision.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets are accepted on behalf of the public as heretofore stated; that those certain abutters' rights of access, together with the easements with the right of ingress and egress for the construction and maintenance of sewer and drainage facilities, all as granted and shown on this map within this subdivision, are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
