RESOLUTION NUMBER R- 260868 Adopted on JUN 04 1984

WHEREAS, existing law does not clearly prohibit an unlicensed person from driving a motor vehicle in an offstreet parking facility; and

WHEREAS, AB 2283 (Killea) would clarify that unlicensed drivers are prohibited from operating vehicles in offstreet parking facilities and that vehicles driven or standing in such facilities must be registered and would also prohibit a person in control of a vehicle from permitting an unlicensed person to drive the vehicle in an offstreet parking facility; and

WHEREAS, Assemblywoman Killea introduced this bill as a result of an accident in a shopping center parking lot in San Diego, wherein, an unlicensed driver was attempting to park a vehicle and the vehicle jumped the curb and crashed into an ice cream parlor, injuring nine persons; and

WHEREAS, under existing law, persons convicted of specified sex offenses or attempted sex offenses are required to register with the local law enforcement agency where they reside, but, there is no such requirement for persons convicted of arson or attempted arson; and

WHEREAS, AB 2818 (Johnston) (as amended March 20, 1984) would give judges the discretion to require persons convicted of arson or attempted arson to register with the law enforcement agency of their place of residence; and

WHEREAS, the Intergovernmental Relations Department

analyzed both proposed bills and recommended to the Rules Committee in IRD Report No. 84-27, dated May 9, 1984 that both bills be supported; and

WHEREAS, the Rules Committee reviewed the analyses of both bills on May 14, 1984 and approved the recommendation to support said bills; and

WHEREAS, the Rules Committee now forwards the matter of supporting both bills to the full Council with a recommendation to support them; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that this Council, upon recommendation of the Rules Committee and after review of IRD Report No. 84-27, dated May 9, 1984, does hereby express its support for AB 2283 (Killea) - Vehicle Code Enforcement in Parking Lots, and AB 2818 (Johnston) -Registration of Arsonists.
