

RESOLUTION NUMBER R-260872

Adopted on JUN 4 1984

BE IT RESOLVED, by the Council of The City of San Diego, that pursuant to authority conferred by and in accordance with the provisions of Section 86.04 of the San Diego Municipal Code, a PARKING TIME LIMIT OF THREE HOURS, be and the same is hereby established on the following street in said City:


Westerly side of Coast Boulevard between Cave Street and the north intersection with Coast Boulevard South, to be effective between the hours of 8:00 a.m. and 6:00 p.m., Saturdays, Sundays, and holidays excepted.

BE IT FURTHER RESOLVED, that the installation of the necessary signs and markings be and the same is hereby authorized to be made on said street, and the regulations hereinabove imposed shall become effective upon the installation of such signs.

BE IT FURTHER RESOLVED, that the parking restrictions described herein shall be effective for a period of one year from and after the installation of the signs imposing the restriction.

BE IT FURTHER RESOLVED, that the City Manager is hereby directed to report to the City Council in six months on the implementation of the parking restriction.
